NOW, THEREFORE, BE IT RESOLVED, that a special election be called, and said special election is hereby called for the 30th day of September, 1938, at which time there shall be submitted to the qualified electors and taxpayers of Tulsa County, Oklahoma, the question of whether or not a new Court House and Jail shall be erected for Tulsa County, Oklahoma, and bonds in the amount of \$750,000.00 be issued by Tulsa County for the cost of the erection thereof; said election to be held by the regular election officials of Tulsa County, Oklahoma, and at voting places so designated as the regular precinct voting places as selected by the Election Board of Tulsa County, Oklahoma. The proposition to be submitted to the voters at said election to be in the following form:

Shall Tulsa County, State of Oklahoma, erect a new Court House and Jail and issue and sell bonds of Tulsa County, in the amount of \$750,000.00 to pay for the erection thereof?

That the ballot used at said election shall set forth the proposition above set forth, and shall contain the following words:

- First, for the erection of a Court House and Jail and the issuing of bonds to pay therefor.
- Second, against the erecting of a Court House and Jail and the issuing of bonds to pay therefor.

(If the voter desires to vote for the above proposition he shall stamp X in the first : _:. If the voter desires to vote against the said proposition he shall stamp X in the second : _:.)

Oklahoma, shall cause ballots to be printed in substantially the form set forth above, but that different colored ballots shall be provided; that is, ballots of one color for the qualified electors and ballots of another color for taxpayers; that is, persons who have actually paid real or personal taxes in the County and have ar eccipt therefor dated within twelve months prior to the date of the election; that is, twelve months prior to the 30th day of September, 1938; and the election officials are further directed to keep a record of the voters who vote as taxpayers, and also a record of the voters who vote as qualified electors, and to canvas and count the votes cast by taxpayers separate and apart from the other votes cast, then to count all votes cast including the votes cast by taxpayers, and to make a return of said election and the result of the MANNEY count of the votes of taxpayers and all the votes cast.

BE IT FURTHER RESOLVED that notice of said election should be given for thirty days and the Board of County Commissioners finds that there is no weekly newspaper of general circulation published in the County seat of Tulsa County, Oklahoma, and that, therefore, notice of sale election shall be given by posting of notices thereof in five public places within the County, and the County Clerk is hereby authorized and directed to this day cause notice of said election to be posted in five public places in Tulsa County, Oklahoma, and to make a meturn showing that he has so done to this Board, which return shall be and is hereby made a pert of these proceedings; and in order that the electors of Tulsa County, Oklahoma, shall have actual knowledge of such said election, and in order that they may participate therein, IT IS FURTHER ORDERED that notice of said election be and the same is hereby ordered published in the Tulsa Daily World and the Tulsa Tribune, newspapers published in the City of Tulsa, Oklahoma, with general circulation throughout the County, commencing August 31, 1938, and to and including September 29, 1938; said notice to be in the following form:

NOTICE OF SPECIAL EELCTION UPON THE QUESTION OF WHETHER OR NOT A NEW COURT HOUSE AND JAIL SHALL BE ERECTED BY TULSA COUNTY, AND BONDS IN THE AMOUNT OF \$750,000.00 BE ISSUED AND SOLD TO PAY THEREFOR.

To all qualified electors and voters of Tulsa County, Oklahoma.
