

REPORT NO. 12.

Gentlemen:-

I am herewith informing you of the condition and progress of the special services and regular auditing services assigned to the State Examiner and Inspector's Staff in the Service of Tulsa County. This report covers the period from our last report, to-wit: May 29th. 1922, up to and including the close of business, SUNDAY June 11th, 1922.

#### CLAIMS

We are returning to you the following claims with our recommendations:

We are recommending that these claims be disallowed for the reason that the same are not legal charges against the County. Both claims are for rewards for the capture of Eugene Williams and Arthur Allen, alleged hi-jackers.

The claim of J.O.Campbell for \$7.20 Tax refund, is recommended for disallowance, for the reason that the County Treasurer refused to approve the same.

The claim of F.F.Nelson for \$16.00 for special services in the re-count on the contest in the City Primary is recommended for disallowance for the reason that the law does not authorize members of the Election Board to receive compensation for extra services. All such services are included in the regular compensation, as by law fixed.

The claim of Dr. G.H.Butler, County Physician, for special autopsy services, in the sum of \$25.00 is recommended for disallowance for the reason that this service is included in claimants monthly salary, as by law fixed.

#### ERRONEOUS ASSESSMENTS.

We are herewith returning for your consideration 23 applications for erroneous assessment, with the following recommendations:

#### JUSTICE OF THE PEACE AUDITS

There has been filed with the County Clerk the official and approved Audits of Chas. Oberst, Justice of the Peace and G.M.Litson, Justice of the Peace. I recommend that said Justices of the Peace be notified to appear before the Board today in matters connected with their respective audits.

In the audit of H.J.Gray, Justice of the Peace, the hearing of the same was continued to this date. Mr. Gray has notified me that it will be necessary for him to have further time to investigate matters in controversy. I have advised him to appear before you and apply for an extension of time.

#### GENERAL

You are further advised that practically the remainder of this month will be consumed in clearing up all matters, both general and special, in order that we may report thereon at your last meeting. Our purpose in doing this is to handle all unfinished matters heretofore assigned to us so that at the beginning of the ensuing fiscal year we may begin our services, as outlined in the program heretofore adopted by you.

We are giving our Special attention to the Budget work for the several county and township funds. We will have the County Budget ready for your consideration a few days after July 1st. We are making a complete detailed fund audit of the General, Sinking, State
