

Highway Construction and County Road Maintenance Funds, and this audit will be embraced in a report and will be in detail. We will likewise perform the same services in the township funds. This will be the beginning of our program in making monthly fund balance sheets of the several funds during the next fiscal year.

In preparing our Budget and the Appropriations for the ensuing Fiscal Year it is our intention to so arrange accounts and appropriations that all classes of expenditures will be carried under appropriate titles and we will also increase the number of accounts above the regular accounts as set out in the Budget, for the purpose of taking care of claims for expenditures, which during the fiscal year were necessarily classified irregularly. The Statute providing for the Budget fixes certain departments and certain specific accounts therein for which appropriations are to be made, but the same Statute expressly authorized the duly constituted authorities of a municipality to create other accounts for legal expenditures other than those enumerated.

It will be our purpose, as above stated, to create new accounts and provide appropriations therefore, to take care of claims that of necessity and by reason of lack of proper classification in this year's Budget have been charged to improper accounts in the several departments.

While we are at work on the audit of S.J. Maxey, Justice of the Peace we will make no effort to complete this audit until we have the above mentioned work completed and out of the way, although the idle moments of our staff will be used on the Maxey Audit.

All members present voting in the affirmative, motion was declared carried.

Motion was made by Geo.E. Gilmore, that the Court Clerk be instructed to furnish a list of those who are entitled to compensation under the Widow's and Orphans Pension Account, as ordered by the Judge of the County Court. Motion seconded by F.M. Wooden. All members voting in the affirmative, the motion was by the Chairman declared carried.
