

The following Resolution was introduced by Mr.Bohnefeld, who moved its adoption and the motion to adopt was duly seconded by Mr.North, and by the Chairman ordered read:

R E S O L U T I O N

WHEREAS, for the purpose of constructing a highway through and across a certain parcel of land in Section Thirty Four (34) Township Nineteen (19) North,Range Twelve (12) East,Tulsa County,Oklahoma it is necessary to acquire an Easement across said parcel of land more particularly described as follows:

"A strip of land 10.25 feet wide for additional right of way for highway purposes, said strip being adjacent to and south of the present County road right of way on the north end of the west 25.5 acres of NE $\frac{1}{4}$ of NW $\frac{1}{4}$ of Section 34, T 19 N., R 12 E.,Tulsa County containing 0.20 acre, more or less. The present County road right of way at the north end of the tract and south of the section line is 24.75 feet" .

AND, WHEREAS, Tulsa County has been unable to affect an amicable settlement in the matter of the said parcel of land owned by Wm.H.WARE AND VADA M WARE.

AND, WHEREAS, it is necessary to acquire an EASEMENT across said parcel of land for right of way for highway purposes by condemnation proceedings.

NOW, THEREFORE, BE IT RESOLVED, that the County Attorney, in the name of this Board, for and on behalf thereof, be and he is hereby instructed to institute proceedings in the District Court of this County for the purpose of condemning said above described parcel of land for right of way for highway purposes.

The vote on the motion to adopt the resolution was unanimously carried and the Resolution adopted.

The following Resolution was introduced by Mr.Bohnefeld, who moved its adoption, and the motion to adopt was duly seconded by Mr.North, and the Chairman ordered the same read:

R E S O L U T I O N.

WHEREAS, for the purpose of constructing a highway through and across a certain parcel of land in Section Thirty Three (33) Township Nineteen (19) Range Twelve (12) East Tulsa County,Oklahoma, it is necessary to acquire an EASEMENT across said parcel of land more particularly described as follows:

"A strip of land 10.25 feet wide for additional right of way for highway purposes in the North ends of Lots 5,6,7 and 8, Block 19, Amended Plat of South Haven in the W $\frac{1}{2}$ of NE $\frac{1}{4}$ of Section 33, T 19 N., R 12 E.,Tulsa County, Oklahoma, said strip being adjacent to and south of that portion of the present County right of way on the North line of said Section 33, which is adjacent to said Lots 5,6,7 and 8, Block 19, and contains 0.024 acres. The present County road right of way south of the North line of the W $\frac{1}{2}$ of NE $\frac{1}{4}$ of Section 33, is 24.75 feet wide. After the addition of 10.25 feet, the right of way south of the section line will be 35 feet wide".

AND, WHEREAS, Tulsa C_ounty has been unable to affect an amicable settlement in the matter of said parcel of land owned by THE ESTATE OF THOS E HUGHES.

AND, WHEREAS, it is necessary to acquire an EASEMENT across said parcel of land for right of way for highway purposes by condemnation proceedings.

NOW, THEREFORE, BE IT RESOLVED, that the County Attorney, in the name of this Board, for an on behalf thereof, be and he is hereby instructed to institute condemnation proceedings in the District Court of this County for the purpose of condemning said above described parcel of land for right of way for highway purposes.

The vote on the motion to adopt the Resolution was unanimously in the affirmative and by the Chairman declared carried and Resolution adopted.

R E S O L U T I O N.

WHEREAS, for the purpose of constructing a highway through and across a certain parcel of land in Section Twenty Eight (28) Township Nineteen (19),North,Range Twelve (12) East,Tulsa County,Oklahoma, it is necessary to acquire an EASEMENT across said parcel of land more particularly described as follows:

"A strip of land 10.25 feet wide for additional right of way for highway purposes, said strip being adjacent to and north ofmthe present County road right of way on the South line of the W $\frac{1}{2}$ of SE $\frac{1}{4}$ of Section 28, T 19 N., R 12 E., Tulsa C_ounty,Oklahoma, except such portion of the 10.25 feet strip of land as is occupied by the right of way of the Oklahoma Union Railway Company, and containing 0.30 acre, more or less". The present County road right of way north of the south line of the W $\frac{1}{2}$ of SE $\frac{1}{4}$ of Section 28, is 24.75 feet wide.

AND,WHEREAS, Tulsa C_ounty has been unable to affect an amicable settlement in the matter of the said parcel of land owned by JOSEPH M HARRINGTON AND JAMES & MARY L. HARRINGTON.

AND, WHEREAS, it is necessary to acquire an EASEMENT across said parcel of land for right of way for highway purposes by condemnation proceedings.

NOW, THEREFORE, BE IT RESOLVED, That the C_ounty Attorney, in the name of this
