RESOLUTION AGREEING TO MAINTAIN AND KEEP IN
REPAIR THE FLOOD-WAY STRUCTURE AT BLACK BOY
CREEK, NOW BEING CONSTRUCTED BY THE U. S.
GOVERNMENT, UNDER THE M.K.T RAILWAY, SAND
SPRINGS RAILWAY, AND US. HIGHWAY NO. 64, AS
A PART OF IMPROVEMENTS OF TULSA COUNTY
DRAINAGE DISTRICT NO 12, IN TULSA COUNTY
OKLAHOMA.

WHEREAS, the U. S. Government, through its officers, Agents and Employees, viz; the U. S. District Engineers, are now engaged in constructing a Flood-way structure at Black Boy Creek, as a part of the plan and scheme of improvements to control flood waters of Arkansas River within and adjacent to said Tulsa County Drainage District No. 12, and

WHEREAS, Oklahoma State Highway Commission, Sand Springs Railway Company and M-K-T Railway Company have requested that Tulsa County Drainage District No. 12, pass a resolution, committing and obligating said Drainage District to maintain and keep in a good state of repair, when finished and completed, said Flood-way structure at Black Boy Creek, within said District.

NOW, THEREFORE, it is hereby RESOLVED, by TULSA COUNTY DRAINAGE DISTRICT NO. 12, that said Flood-way Structure at Black Boy Creek, shall and will be by said Drainage District, for ever maintained and kept in a state of good repair, when completed, as a material part of said Drainage District project; and said Drainage District does now hereby, by this Resolution, give full assurance to all parties interested, that such Flood-way Structure will be, at all times, kept in a good state of repair, and free and clear of all obstruction, so that it may serve the purposes for which it was built.

THEREUPON, upon motion made by Commissioner Greer, and seconded by Commissioner Kinkaid, and a roll call and vote being had thereon, the Chairman of said Board, declared said Resolution unanimously adopted.
