The following Resolution was introduced by Mr.North, who moved its adoption; said motion being seconded by Mr.Dickey. Chairman Hedgecock ordered the Resolution read:

R E S O L U T I O N

WHEREAS, for the purpose of constructing a highway through and across certain land in Section Thirty Two (32), Township Nineteen (19) North, Range Thirteen (13), East it is necessary to acquire a strip of land particularly described as follows:

A strip of land for public highway purposes, said strip being the west forty (40') feet of the N $\frac{1}{2}$  of N $\frac{1}{2}$  of SW $\frac{1}{4}$  of SW $\frac{1}{4}$  of NW $\frac{1}{4}$  of Section 32, Twp 19 N., R 13 E., Tulsa County, Oklahoma; containing 0.06 acres, more or less, in addition to the present county road right of way which right of way is 24'-9" on each side of the section line"

AND, WHEREAS, Tulsa County has been unable to affect an amicable settlement in the matter of the said strip of land owned by H A Bieber,

AND, WHEREAS, it is necessary to acquire said strip of land for right of way purposes by condemnation proceedings,

NOW, THEREFORE, BE IT RESOLVED, That the County Attorney, in the name of this Board, for and on behalf thereof, be and he is hereby instructed to institute condemnation proceedings in the District Court of this County for the purpose of condemning said above described tract of land for County Highway Purposes.

All voting in the affirmative, motion was declared carried.

AND, WHEREAS, Tulsa County has been unable to affect an amicable settlement in the matter of the said strip of land owned by JOHN H STAIGER.

AND, WHEREAS, it is necessary to acquire said strip of land for right of way purposes by condemnation proceedings.

NOW, THEREFORE, BE IT RESOLVED, That the County Attorney, in the name of this Board fore and on behalf thereof, be and he is hereby instructed to institute condemnation proceedings in the District Court of this County for the purpose of condemning said above described tract of land for County Highway Purposes.
