Commencing at a point on the West line of Said NE $\frac{1}{4}$ of the NW $\frac{1}{4}$ of the NW $\frac{1}{4}$ of said Section 34-19-12, said point being 267.1 feet south of the Northwest corner thereof; thence in an Easterly direction to a point, said point being 22 feet East and 265 feet South of the Northwest corner of said NE $\frac{1}{4}$ of the NW $\frac{1}{4}$ of the NW $\frac{1}{4}$ of said Section 34-19-12; thence East along a line parallel to the North line of said Section 34-19-12, to a point on the East line of the West 260 feet of said NE $\frac{1}{4}$ of the NW $\frac{1}{4}$ of the NW $\frac{1}{4}$ of said Section 34-19-12, said point being 265 feet South of the North line of said Section; thence South and parallel to the West line of said NE $\frac{1}{4}$ of the NW $\frac{1}{4}$ of the NW $\frac{1}{4}$ of said Section 34-19-12, a distance of 194.6 feet to a point; thence in a Westerly direction to a point on the West line of said NE $\frac{1}{4}$ of the NW $\frac{1}{4}$ of the NW $\frac{1}{4}$ of said Section 34-19-12, said point being 474 feet South of the Northwest corner thereof; thence North along the West line of said NE $\frac{1}{4}$ of the NW $\frac{1}{4}$ of the NW $\frac{1}{4}$ of said Section 34-19-12, a distance of 206.9 feet to the place of beginning,

excepting therefrom the buildings and improvements thereon which grantors agree to remove immediately, the County to pay therefor the sum of \$13,000.00 upon claim executed by said owners.
