The work of preparing the Budgets of the several County Funds and the Thirteen Townships is now in progress and as soon as the County Treasurer completes his apportionments for the month of June 1922 the work will be completed. Nothing unforeseen happening we will be able to report on this work by the 10th. of July or sixty days earlier than the work has ever been previously done. The cost of this work will be but nominal to the tax payers this year for the reason that we have absorbed all of the previous Financial and Fund Services done by us thru out the year, thereby practically eliminating the necessity of duplicating much of the work for the budgets.
