Motion was made by W L North, seconded by J S Shaver, that the SAND SPRINGS HOME LIGHT AND POWER DEPARTMENT, be and they are hereby given permission to install lights on the County Highways, as set out in the following Agreement:

This Agreement entered into this twentieth day of Octoner, Nineteen Hundred and Twenty Four, by and between the Sand Springs Home Power and Light Department of Sand Springs, Oklahoma, hereinafter called the Company, Party of the first part, and the Board of County Commissioners of Tulsa County, Oklahoma, party of the second part, hereinafter called the Comsumer. WITNESSETH:

- 1. Consumer being desirous of illuminating certain points on the Paved Highway between Tulsa andn Sand Springs hereby directs the Company to provide, install and operate lighting units at points hereinafter specified.
- 2. Lighting units shall be installed at each of the following locations, viz: At the Highway Crossings at Lake Station, at Bruner Station, at Lawnwood Station, at Medio Station, at Glenn Station, at Vern Station, at Home Gardens Station, at Parkview Station, at Railroad crossing near Hale Station, at Joe Station, and at the highway crossing between Vern and Glenn Stations.
- 3. The Company agrees to furnish and install on electric light poles at points indicated, a six foot mast arm and attach to same a suitable type R L M Reflector and equip same with 300 Watt Mazda Lamp, together with necessary wiring and control switch, and further agrees to furnish lamp renewals as required from time to time and to keep the installation in the best operating condition.
- 4. The Company agrees to keep lights burning each night in the year beginning thirty minutes after sun down and ending thirty minutes before sunrise.
- 5. Consumer agrees to pay the Company the sum of Six Dollars and Seventy Five cents (\$6.75) each month for each unit installed, payments to be made at the office of the Company in Sand Springs, Oklahoma.
- 6. It is further understood that service under this agreement, shall continue for a period of two years from date of connection. Provided, however, that in the event any portion of the territory covered by this agreement shall be taken into the corporate limits of the City of Tulsa, during the period covered hereby, Consumer shall then be relieved of further payment on such units as may then be accated in such portion taken into the City Limits of Tulsa.
- 7. Any additional units Consumer may desire to have installed from time to time shall be subject to the same terms and conditions as specified above, provided such additional locations are adjacent to and accessible to low voltage primaries or secondaries.
