MONDAY, JANUARY 3RD, 1944

The Board of County Commissioners met at regular session on Monday, January 3rd, 1944, at the hour of 10:00 o'clock A. M., with all members present: J. B. Gray, Chairman, Curtis Greer and Robt. L. Kinkaid, Members, Andy Stokes, County Clerk.

J. B. Gray, Chairman presiding, the following business was transacted.

Motion made by Commissioner Greer, seconded by Commissioner Kinkaid to reject the City of Tulsa's Fire Department's claim in the amount of \$1,851.43 for three fire runs to the Fair Grounds during the month of November, 1943. Upon roll call, all members voting in the affirmative, motion was by the Chairman declared carried.

Motion made by Commissioner Gray, seconded by Commissioner Kinkaid to approve the appointment of Frank Yeager, as extra deputy sheriff, in the office of A. Garland Marrs, Sheriff, at a salary of \$175.00 per month. Upon roll call, all members voting in the affirmative, motion was by the Chairman declared carried.
