MEMORANDUM OF AGREEMENT FOR FARM AND HOME DEMONSTRATION.

This instrument, entered into this 14th. day of June, 1922, is to witness that the above commissioners agree to co-operate with the Extension Division of the Oklahoma Agriculture and Mechanical College and the U.S. Department of Agriculture in conducting Farm and Home Demonstration work in Tulsa County, Oklahoma, during the year 1922-1923, under the following terms:

The County Commissioners agreeto pay Two Hundred (\$200.00) Dollars per month on the salary; of an Agent in charge of Farm Demonstration work for a period of twelve months beginning July 1st. 1922, and

The County Commissioners agree to pay One Hundred Twenty (\$120.00) Dollars per month on the salary of Home Demonstration Agent for the period of twelve months, beginning July 1st 1922.

The County Commissioners agree further to put up the following amount to apply on the expense of the County Agent work as carried on in this County: Forty four Hundred Sixty \$4460.00) Dollars for County Agent's office and Seven Hundred (\$700.00) Dollars, expense account of Home Demonstration Agent.

The Extension Division of the Oklahoma Agricultural and Mechanical College co-operating with the U.S.Department of Agriculture shall select the Agents, and shall pay One Hundred Ten (\$110.00) Dohlars per month on salary of Farm Demonstration Agent, and they will also pay One Hundred Ten (\$110.00) Dollars per month on salary of Farm Demonstration Agent, furnish them with the franking privilege, stationery, literature and instructions. The Extension Division shall superintend the work of the Agents and pay their expenses when duly authorized to make trips outside of the County on official business.

The Agent's salary shall be payable on or after the first of each month on certificate from the Extension Division of the A & M College that the work has been duly performed.

The County Commissioners agree to pay Two Hundred (\$200.00) Dollars per month on the salary of a specialist in co-operative farm marketing as assistant to work under the supervision of the County Agent for a period of twelve months beginning July 1st. 1922, with an expense account of Twenty Six Hundred (\$2600.00) Dollars.

This Agreement shall be in force for the Farm Demonstration Agent twelve months beginning July 1st. 1922.

This Agreement shall be in force for the Home Demonstration Agent twelve months beginning July 1st. 1922.

This agreement shall be in force for the specialist in co-operative farm marketing twelve months, beginning July 1st. 1922.
