MANAGEMENT CONFERENCE  
April 14, 1993

The Board of County Commissioners of Tulsa County met at 9:30 a.m., with the following members present: Robert N. Dick, Chairman; Lewis Harris, John Selph. Members absent: none. Others present: Stanley Glanz, John Cantrell, Clay Edwards, Wayne Carr, Dave Hill, Ray Jordan, Leroy Jones, Bill Thompson, Gerald Griffin, Buck Rudd, Dennis Semler, Robin Lacey, Neal Kennedy, Manny Gamallo, and Pam Hayes.

Chairman called the meeting to order at 9:32 a.m., and the following business was transacted:

Harris distributed an update of the actions taken by the ad hoc committee to study tax resale properties and advised the board Robin Lacey had been hired to help solve the problems. Lacy's salary will be paid from the tax resale property fund. Cantrell said there would be no change in the process of selling properties; state law is specific on the disposal of such property. Lacey's job is simply to find people to make bids on the property.

Glanz distributed materials detailing jail occupancy and stated there are 636 inmates presently in the jail. He updated the board on the inmate
