P E T I T I O N .

Comes now the Eastern Oklahoma Light and Power Company, a Corporation, and respectfully represents and shows that it is a corporation, duly organized and existing under and by virtue of the laws of the State of Oklahoma, and that it is authorized by its Charter to furnish electricity for light, heat and power to various inhabitants and municipalities within the County of Tulsa, Oklahoma, that this applicant has franchises with various cities of this County, and other Counties, to furnish said municipalities and the inhabitants thereof with electricity, and it will be necessary to lay, maintain, construct and erect on the following public highways in said County, poles, wires and other apparatus and appliances necessary to transmit said electricity to said municipalities, to-wit:

Commencing at a point, the Southeast Corner of the City Limits of Skiatook, Oklahoma, running east along the Section lines between Sections 24 and 25, Township 22 North, Range 12 East, and Sections 19 and 30, 20 and 29, 21 and 28, 22 and 27, 24 and 25, Township 22 North, Range 13, East; and Sections 19 and 30, 20 and 29, Township 22 North, Range 14 East to the City Limits of Collinsville, Oklahoma; and

Commencing at a central point at the intersection of the Section lines between Sections 23 and 24, 25 and 26, Township 22 North Range 13 East, running north on section line between Sections 23 and 24, 13 and 14, 11 and 12, 1 and 2, Township 22 North, Range 13 East to the Washington County, Oklahoma Boundary line.

Your Petitioner further states that it is desirous that the installation of said poles, wires, apparatus and other appliances be made under the direction of the County Engineer, and in such places and manner consistent with necessity, and least interfering with other public uses of said highways, and will not unnecessarily obstruct said highways and shall within a reasonable time be placed as near as practicable in as good condition and repair as before such construction, at the expense of this Petitioner.

Your Petitioner further states that in the event the Board of County Commissioners decides at any time to widen the highways used by said Petitioner that said Corporation
