The following Resolution was introduced by Commissioner North, who moved its adoption, and the motion to adopt was seconded by Commissioner Bohnefeld, and the Chairman ordered the Resolution read:

R E S O L U T I O N .

WHEREAS, for the purpose of constructing a highway through and across a certain parcel of land in Section 24, Township 19, North, Range 12 East, Tulsa, County, Oklahoma, it is necessary to acquire an easement across said parcel of land more particularly described as follows:

of th "A strip of land 10.25 feet wide for additional right of way for highway purposes, said strip being adjacent to the south of the present County road right of way on the North end of the East five (5) acres of the West 30.5 acres of the NE $\frac{1}{4}$ of NW $\frac{1}{4}$ of Section Thirty Four (34) Township Nineteen (19) North, Range Twelve (12) East, Tulsa County, Oklahoma, containing 0.04 acres, more or less"

The present County road right of way at the North end of the tract and South of the Section line is 24.75 feet.

AND, WHEREAS, Tulsa County has been unable to affect an amicable settlement in the matter of the said parcel of land owned by CHARLES H MONDY and MARIE MONDY, his wife, and W H WARE, as Mortgagee.

AND WHEREAS, it is necessary to acquire an EASEMENT across said parcel of land for right of way for highway purposes by condemnation proceedings.

NOW, THEREFORE, BE IT RESOLVED, That the County Attorney, in the name of this Board, for an on behalf thereof, be and he is hereby instructed to institute proceedings in the District Court of this County for the purpose of condemning said above described
