Motion was made by Ira Short that County Attorney be instructed to institute proceedings against Mr. G.M.Litson, Justice of the Peace in and for District No.4, for the collection of \$115.20 which is due Tulsa County account of recent audit. Motion was lost for want of second.

Motion was made by ira Short, seconded by Geo.E.Gilmore, that Justice of the Peace in and for District No. 4, H.J.Gray, be instructed to pay the sum of \$520.82 in settlement of charges preferred against his office in a recent audit. All members voting in the affirmative, the motion was declared carried.

Therfollowing reports were approved and ordered filed: Court Clerk's Sheriff's Foreign Fees Report for the Month of April, 1922. The following County Depository Bonds were approved: Massachusetts Bonding and Insurance Company as Surety and Liberty National Bank as Principal in the amount of Five Thousand (\$5,000.00) Dollars. Massachusetts Bonding and Insurance Company as Surety and Liberty National Bank as Principal in the sum of Fifteen Thousand (\$15,000.00) Dollars. The Exchange National Bank of Tulsa, Oklahoma as Principal and Exchange Trust Company as Surety in the amount of One Hundred Seventy five thousand Dollars (\$175,000.00).

There being no further business to come before the Board at this time same was ordered adjourned until the hour of Two (2:00) o'clock P.M. June 27th. 1922.

Pursuant to adjournment, the Board of County Commissioners met in their office at the hour of Two (2:00) O'clock P.M. with the following members present. Geo.E.Gilmore, Chairman, Ira Short, Member, O.D.Lawson, County Clerk, Ex-Officio Secretary. F.M.Wooden, Member absent account sickness,

Motion was made by Ira Short, seconded by Geo.E.Gilmore that the matter of the Audit of G.M.Litson, Justice of the Peace in and for District No.4, be considered settled insofar as the financial side is concerned, but his resignation will be considered effective on and after July 10th. 1922.

RESOLUTION

WHEREAS, the attention of this Board has been called to certain rumors and statements made by certain parties that certain Justices of the Peace who have been heretofore audited had failed, in some instances, to enter and have shown upon the Criminal Docket certain criminal actions in which fines and costs were paid, and

WHEREAS, it is the intention of this Board to cause an investigation to be made for the purpose of ascertaining the correctness or incorrectness of such rumors and statements, therefore, BE IT RESOLVED, that Ed.O.Cassidy, Special Deputy State Examiner and Inspector be and he is hereby directed and authorized to make an investigation in this matter and report thereon to this Board.

Motion was made by Geo.E.Gilmore, seconded by ira Short that the above Resolution be adopted. Upon roll call, the motion was declared carried.

There being no further business to come before the Board at this time same was ordered adjourned to meet again on Monday, July 3rd. 1922, at 10:00 o'clock A.M.
