RESOLUTION

WHEREAS, all of Lot 17 and a portion of Lot 16, Block 19, South Haven Addition, Tulsa County, Oklahoma, is needed by the County of Tulsa in connection with acquisition of right-of-way for the 51st Street Project; and

WHEREAS, said property can be acquired by amicable settlement from the owners, Sherman Brown and Dora Brown, his wife, for a consideration of \$2,000.00, which amount is deemed to be fair and reasonable.

NOW THEREFORE BE IT RESOLVED that the County purchase Lot 17, Block 19, South Haven Addition, and a portion of Lot 16, Block 19, South Haven Addition, Tulsa County, Oklahoma, according to the recorded amended plat thereof, being more particularly described as follows, to-wit:

Beginning at the Southwest corner of said Lot 16, thence North along the West line of said Lot 16 a distance of 30 feet to a point, thence Southeasterly to the Southeast corner of said Lot 16, thence West along the South line of said lot to the Southwest corner of said Lot 16, and point of beginning,

excepting therefrom the buildings and improvements thereon which grantors agree to remove immediately, the County to pay therefor the sum of \$2,000.00, upon claim executed by said owners.

RESOLUTION

WHEREAS, lots 1 and 2, of Block 3, Suburban Addition, Tulsa County, Oklahoma, are needed by the County in connection with the acquisition of right-of-way for the 51st Street Project; and

WHEREAS, said property can be acquired by amicable settlement from the owner, John Skeith, for a consideration of \$7,250.00, which amount is deemed fair and reasonable.

NOW THEREFORE BE IT RESOLVED that the County purchase Lots 1 and 2, Block 3, Suburban Addition, a Subdivision in the NE $\frac{1}{4}$ of the NW $\frac{1}{4}$ of Section 33, Township 19 North, Range 12 East, Tulsa County, Oklahoma, and the improvements thereon, paying therefor the sum of \$7,250.00 upon claim executed by said owner.

RESOLUTION

WHEREAS, Oklahoma Natural Gas Company, a Delaware corporation of Tulsa, Oklahoma, has applied for permission to cross or parallel, with a 4 and 2 inch gas pipe line a county highway at the location shown on the accompanying map and described as follows:

Four (4) inch gas pipe line crossing county highway between Sections 14 and 23, Township 18 North, Range 12 East, also county highway at the quarter section line common to Sections 23 and 24, Township 18 North, Range 12 East; also,

Two (2) inch gas pipe line crossing county highway between Sections 25 and 26, and between Sections 25 and 36, Township 18 North, Range 12 East.

AND, WHEREAS, applicant has agreed to keep said line and its appurtenances in good repair at all times, and to remove said line at its own expense when such removal is necessary for the maintenance, repair or widening of the highway, and to comply with all the rules of the Board of County Commissioners and the laws of the State of Oklahoma in the laying and maintenance of said pipe line, and it appears that the said application should be approved and permission granted as requested.

NOW THEREFORE, be it resolved by the Board of County Commissioners of Tulsa County, Oklahoma that Oklahoma Natural Gas Company be, and it hereby is granted permission to lay and maintain a 4 and a 2 inch gas pipe line at the location above specified.

At a regular meeting of the Board of County Commissioners of Tulsa county, Oklahoma, held on the 22nd day of October, 1951, two members being present, the above resolution was introduced, its adoption moved and seconded, the vote upon said resolution being as follows:
