It further appearing from the representations of said Fields Ready to Wear, Inc., and the evidence taken that said Fields Ready to Wear, Inc., should not be compelled to pay all of said taxes so assessed against Macy's Inc., but that the sum of \$639.91 is a fair and reasonable tax to be assessed against Field's Ready to Wear, Inc., on the assets so taken over by them.

BE IT, THEREFORE, RESOLVED, That the County Treasurer be, and he is hereby ordered and directed to adcept from said Field's Ready to Wear, Inc., the sum of \$639.91 together with the additional sum of \$367.09, heretofore assessed against Field's Ready to Wear, Inc., or a total of \$1,000.00 in full satisfaction of any and all taxes due and owing bybsaid Field's Ready ot Wear Inc., for the years 1929 and 1930, and that said Treasurer issue his receipt in satisfaction thereof, the payment of said taxes, however, to in no way relieve or release the said Macy's Inc., from any balance of taxes that may be due.
