RESOLUTION

WHEREAS, Oklahoma Natural Gas Company, a corporation of Tulsa, Oklahoma, has applied for permission to attach a four (4) inch natural gas pipe line to the county owned bridge crossing Polecat Creek in the Southeast quarter of the Southeast quarter of the Northeast quarter and the Northeast quarter of the Northeast quarter of the Southeast quarter of Section 26, Township 18 North, Range 12 East; also, permission to attach a two inch natural gas pipe line to the county owned bridge crossing Coal Creek at approximately the East-West 1/16 section line in the Southeast quarter of Section 26, Twonship 18 North, Range 12 East.

AND, WHEREAS, the Applicant has agreed to keep the said lines in good condition at all times, to remove either of said lines if such removal is necessary for maintenance or repair to the bridge, and to indemnify Tulsa County for any damage caused to county property by reason of the attachment, maintenance or operation of the said pipe line, and it appears that said Application should be approved.

THEREFORE, be it resolved by the Board of County Commissioners of Tulsa County, Okla., that Oklahoma Natural Gas Company be, and it hereby is granted permission to attach the two said pipe lines to the bridges above mentioned, the lines to be attached in the manner shown by the prints attached to the Application.

RESOLUTION

WHEREAS, Oklahoma Natural Gas Company has made application for permission to cross the property and the levee of said district with one 4-inch gas pipe line, the location of said line being described as follows:

Crossing levee Fifteen feet wide at a point two hundred twenty-three (223) feet South of quarter section line common to Sections 23 and 24, Twonship 18 North, Range 12 East, Tulsa County, Oklahoma.

WHEREAS, the Applicant agrees to bury the pipe line across the levee Thirty inches below the surface of the sides and the top of said levee; to compact all backfall on the levee to its original density; and to replace the top soil and sod removed from the levee in its original condition as nearly as is possible and to attach to said line Two boiler plates Three-eighths inch by Three feet square, one on each side of said levee to prevent movement of the line; and

Applicant further agrees to comply with all rules and regulations of the drainage district and to remove said line when such removal is necessary for the maintenance or repair of the levee; and

Applicant has submitted maps showing the location of the line, and it appears that said permission should be granted.

Now therefore, be it resolved by the Board of County Commissioners of Tulsa County, Oklahoma, acting as Commissioners of Tulsa County Drainage District No. 13, that Oklahoma Natural Gas Company be and it hereby is authorized to install the above described line at the location set out above and in accordance with the maps submitted.
