Motion by Commissioner Morley, seconded by Commissioner Greer, that the following Resolution be adopted. All members voting in the affirmative, motion was by the Chairman declared carried.

RESOLUTION BY THE COUNTY COMMISSIONERS OF TULSA COUNTY

WHEREAS, a great emergency exists because war has come to America, and not only America, but has come to Tulsa and Tulsa County; and

WHEREAS, our lives, our liberty, and our sacred honor, are at stake. Americans everywhere have sprung to the nation's defense and are girding for the struggle. Man power is being mobilized for our armed forces; our industries are mobilizing tools of war; the United States Treasury is mobilizing money, the indispensible "sinews of war", and

WHEREAS, under the direction of the Treasury Department of the United States Government, a bond pledge campaign is now in full swing and will continue until the night of May 14th, 1942; and

WHEREAS, all of us, men and women, with incomes here in Tulsa County, are taking part in this campaign to help win the war, a campaign in which each pledges to invest a certain amount in savings bonds and stamps regularly, week by week, or month by month. Our Government needs a pledge from each of us in order to know how much support it can count on to carry on the war. Our fighting forces need our support, for the money we invest in bonds and stamps help buy them food to eat...uniforms to keep them warm... weapons to fight with! The pledge is now an order, but an indication of how much support each of us expect we can give for the duration of the war; and

WHEREAS, the County Commissioners of Tulsa County, in regular meeting assembled, knowing that every citizen in Tulsa County is a patriotic American and desirous of helping his government in this fight for liverty and democracy,

THEREFORE, BE IT RESOLVED:

That Mr. Joe T. Parkinson, County Treasurer, be appointed Chairman of the bond pledge campaign for all county officials and employees.

BE IT FURTHER RESOLVED:

That said Chairman shall have authority to appoint as many Co-Chairmen as he may require in order that every official and employee of Tulsa County shall have an opportunity to sign one of these pledges on or before Tuesday, May 12; and

BE IT FURTHER RESOLVED:

That any employee or any citizen of Tulsa County who has not signed a pledge by that date will have the opportunity of going to the polling place in his or her precinct on May 14th and there sign said pledge; and

BE IT FURTHER RESOLVED:

That the Chairman and the Co-Chairman cooperate and work with kkix County Administrator, Mr. L. W. Grant, and the City General Chairman, Mr. I. D. Moseley.
