REPORT NO. 14.

Tulsa, Oklahoma July 1st. 1922.

Honorable Board of County Commissioners of Tulsa County, Oklahoma.

Gentlemen:

We are herewith making FINAL Report on the various services assigned to the State Examiner and Inspector's Staff in the service of Tulsa County, for the fiscal year of 1921-22.

About the first of August, 1921, the Honorable Fred Parkinson, State Examiner and Inspector, commissioned me to complete the audit of John D.Porter, Court Clerk, and at the conclusion thereof, to report to the Department for an assignment to other duties. On August 27th. 1921, we began the audit of Mr.Porter, Court Clerk, and the same was completed on the 19th. day of December, 1921.

In may of 1921 and in the fiscal year of 1920-21, and during the administration of your predecessors, by virtue of a resolution passed by them we began the audit of John D. Porter, court clerk, and had a small amount of the preliminary work done at the conclusion of their term, July 5th. 1921 at which time the work was suspended awaiting instructions from your board to continue the work to completion, and on or about the first of August, 1921 your Board authorized the Department to complete the audit.

While this audit has been completed since the 19th. day of December, 1921, it is only filed with you today. At the request of your board, made at the time the audit was closed and ready for assembling into book form, we suspended our work thereon for the purpose of initiating other audits, which, at that time, were, on account of certain conditions
