ORDER

Now, On this 18th. day of April, 1927, the matter of the petition of the TULSA TRUST COMPANY, a corporation, Trustee for mJennie F Brennan and E J Brennan under the terms of a Deed of Trust bearing date of September 15th. 1926 and recorded in the office of mthe County Clerk in Tulsa County, Oklahoma, in Book 647 at Page 530, for permission to lay a water pipe line along, under and across certain highways inmsaid County and State came before the Board of County Commissioners of said County for hearing, and it appearing to the Board thereof that it was just that the said Tulsa Trust Company, Trustee as aforesaid, be permitted to use as much of the highway as designated by the plat filed by said corporation and according to said description which is as follows, to-wit:

Beginning at a point within the SE4 of SE4 of Section 18, Township 19 North, Range 12

East, of the Indian Base Meridian, and running in an easterly direction to a point near the NW corner of the SW4 of the SW4 of Section 17, Township 19 North, Range 13 East of the Indian Base Meridian an approximate distance of one-fourth miles; thereby crossing the North and South section line between Section 17, Township 19 North, Range 13 East, and Section 18, Township 19 North, Range 12 East, together with any public roads or highways that may be crossed by a water pipe line laid in accordance with the blue print map of survey attached hereto and made a part hereof. This line to be known as _____ line, a ____ inch water pipe line.

And, it furtherappearing from the Petition herein that said pipe line will be so constructed as not to interfere ith any of the rights of the general public in the use of said highways; and will be so monstructed in a ccordance with all rules of the County Commissioners and the laws of the State of Oklahoma governing same; and that any damage to said highways occasioned by the cons truction and / or operation of said line will be suitably repaired; and that such repairs, if any, will be kept good.

IT IS MEREBY ORDERED AND ADJUDGED by the Court of County Commissioners of said County that this Petition will be granted and same is hereby granted to the TULSA TRUST COMPANY, Trustee as aforesaid, its assigns and successors in Trust to use as much of the highways as above designated.
