WHEREAS, On the 7th. day of December, 1931, a resolution declaring assessments to pay the costs of water improvements in Sub-District No.1, of Water Improvement District Number Three, Tulsa County, Oklahoma, was passed by the Board of County Commissioners of Tulsa County, Oklahoma, and was duly published on December 10th.1931, as provided by law in Tulsa County, Oklahoma, said Resolution declaring total assessments in said Sub-District on account of said water improvements and the cost thereof in the sum of \$11,775.00, and

WHEREAS, there now remains unpaid on said assessments the principal sum of \$11,775.00, and

WHEREAS, more than thirty (30) days have expired since the date of the publication of the assessing resolution, and the Board of Directors of Water Improvement District No 3, Tulsa County, Oklahoma, has prepared and submitted this Resolution providing for the issuance of negotiable coupon bonds in the aggregate amount of such assessments then remaining unpaid.

NOW, THEREFORE, BE IT RESOLVED, By the Board of County Commissioners of Tulsa County, Oklahoma:

SECTION 1. That there be issued negotiable coupon bonds of Sub-District No.1, of Water Improvement District No.3, Tulsa County, Oklahoma, in the aggregate principal amount of \$11,775.00 which said Bonds shall be Series _____, dated fhe 9th.day of January, 1932, and shall be numbered serially from One (1) to Twenty Three (23), both inclusive, to be of the principal denomination of FIVE HUNDRED DOLLARS (\$500.00) and Bond No. Twenty of the principal denomination of Two Hundred and Seventy Five and no/100 Dollars (\$275.00). All of such bonds shall mature and be payable on or before the 1st. day of October, 1951, and draw interest at the rate of sixper cent (6%) per annum from the date thereof, payable October 1st. 1932, and semi-annually thereafter on the 1st. of April and October of each of the succeeding years until paid. Said Bonds shall have attached thereot interest coupons bearing facsimile signatures of the Chairman of the Board of County Commissioners and the County Clerk of Tulsa County, Oklahoma and sealed with the seal of said County. Said Bonds shall be executed and signed by the Chairman of the Board of County Commissioners and the County Clerkof Tulsa County, Oklahoma, and sealed with the seal of said County. Said Bonds and interest coupons shall be payable at the fiscal agency of the State of Oklahoma, in the City of New York, State of New York, and shall be in the following form to-wit:
