WHEREAS, said Federal Truck being in a state of bad repair and not generally serviceable for the uses and purposes of the Highway Department, to which said Federal Truck belongs and was purchased and paid for from County Highway Funds, and

WHEREAS, the Highway Department is in need of a truck and has found that a trade or exchange can be made with International Harvester Company for an International Truck Motor Number GRD-233-4664 in exchange for the Federal Truck and a further consideration of payment by Tulsa County to International Harvester Company the sum of \$775.00. - -
