REPORT NO. 15.

Tulsa, Okla. July 8th. 1922.

Honorable Board of County Commissioners of Tulsa County, Oklahoma.

Gentlemen:-

I am herewith reporting the progress and condition of the various services assigned to the State Examiner and Inspector's Staff in the service of Tulsa County. This report covers the period from our last report. No. 14, up to the close of business July 8th. 1922.

## BUDGET SERVICES.

Since the second day of July our force has been engaged exclusively in preparing the Budget of the several County and Township Funds. We have completed the Fund Balance Sheet and all of the supporting schedules in the General Fund, and the same are ready to set in the official form of the Financial Statement and Estimated Needs for the Fiscal Year of 1922-23.

We are now engaged in preparing Financial Statements and supporting schedules on the following County Funds:

Sinking Fund.
State Highway Construction Fund.
County Road Maintenance Fund.

and also financial statements and supporting schedules of the funds of the thirteen townships. In addition to setting the results of our work in the official Budget for the Fiscal Year of 1922-23 we are preparing for submission to you the entire work on the County and Township Funds in report form, settingup the financial statements and supporting schedules in detail. We do this in order that your Board and the public may have access to detailed information in every fund during the past fiscal year.

In order that you may be informed as to the results of your operations in the General Fund of the County during the past fiscal year, we are submitting the following information to you.

GENERAL FUND

The total appropriations in the General Fund for the fiscal year 1921-22 were \$1,254,174.13, and to June 30th. 1922 there were claims allowed and warrants issued and registered in payment thereof, in the total amount of \$1,098,477.22. There was transferred from the warrants issued in the fiscal year 1921-22 to the fiscal year 1920-21, the sum of \$916.85 on account of claims for the prior fiscal year being paid with warrants on the fiscal year 1921-22, leaving the net warrants issued against the 1921-22 appropriations of \$1,097,560.37.

On June 30th. 1922, the net balances of the appropriations was the amount of \$156,613.76, and the net balances of appropriations was allocated as follows:

Road and Bridge \$44,998.52 County Road Construction 23,474.43 Separate Schools 66,454.70 For current expense purposes 21,686.11 TOTAL 156,613.76

You will note that for current expense purposes you have but \$21,686.11 in your appropriation to take care of the same and the bulk of the claims chargeable against the past fiscal year and this unexpended balance of appropriations will be presented to you at your meeting
