Motion was made by W L North, seconded by J S Shaver, that the Petition of the Mutual Oil Company be and the same is hereby granted. Said Petition is herewith given:

Comes now the Mutual Oil Company, a Maine Corporation, duly domesticated and authorized to transact business within the State of Oklahoma, and hereby states that it is engaged in the development and operation of lands in Oklahoma for oil and gas mining purposes; that it owns certain leases in Tulsa County, and desires to lay shackle lines from its power located in the Southeast Quarter of Southeast Quarter of Section 6, to wells in the Northeast Quarter of Northeast Quarter of Section 7, Township 19 North, Range 12 East, Tulsa County, and that to do so a portion of the public highways of the County of Tulsa must be crossed.

Your Petitioner also alleges that it will be necessary, to lay said shackle lines under the paved highway between Tulsa and Sand Springs, at a point One hundred feet west of Section Line between Sections 7 and 8; also under Section line road between Sections 6 and 7 at a point One Hundred Thirty Five feet west of Section corner to Sections 5,6,7 and8, Township 19 North, Range 12 East.

WHEREFORE, your Petitioner prays that an order be entered, authorizing it to lay shackle lines or line, for the pumping of wells in the Northeast Quarter of Northeast Quarter of Section 7, Township 19 North, Range 12 East, Tulsa County, and that an order be entered permitting it to lay said shackle line or lines under the paved road between Tulsa and Sand Springs and under section line road between Sections 6 and 7, as described in Paragraph 2 above, provided that all of said work shall be done under the supervision of the County Engineer of the County of Tulsa, and at the exclusive expense of the undersigned, and with the representation tht that the same shall not interfere with traffic along such highways, nor will the pavement or base of said paved highways be disturbed or injured in any manner whatsoever.
