In the matter of the application of the OKLAHOMA NATURAL GAS CORPORATION for permission to lay pipe line along and across certain of the County Highways, the following order was made:

## O R D E R

NOW, On this the 25th. day of April, 1927, the matter of the petition of the OKLAHOMA NATURAL GAS CORPORATION for permission to lay a pipe line along, under and across certain highways in said County and State came up before the Board of County Commissioners of said County for hearing and it appearing to the Board and each of the Commissioners thereof that it was just that the said Oklahoma Natural Gas Corporation be permitted to use as much of the highways as designated by plat filed by said corporation, and according to said description, which is as follows, to-wit:

Beginning at a point near the Southeast Corner of the Northeast Quarter of Section 11, and running thence East approximately One Mile to a point near the Southeast corner of the Northeast Quarter of Section 12 all in Township 18 North, Range 14 East; thereby crossing the north and South Sect on line road between Sections 11 and 12, Township 18 North, Range 14 East, together with any other public roads or highways that may be crossed by a pipe line laid in accordance with blue print made of survey hereto attached and made a part hereof. This line known as "Line C-M 32"

AND it further appearing from the Petition herein that said pipe line will be so constructed as not to interfere ith any of the rights of the general public in the use of said highways; and will be constructed in accordance with all rules of he County Commissioners and the laws of the State of Oklahoma governing same.

IT IS HEREBY ORDERED AND ADJUDGED by the Board of County Commissioners of said County that permission be granted, and the same is hereby granted to Oklahoma Natural Gas Corporation, its successors and assigns, to use as much of the highways as above designated.
