RESOLUTION

The following Resolution was introduced by W L North, who moved its adoption, said motion being seconded by W J Dickey, and the Chairman ordered the Resolution read:

WHEREAS, for the purpose of constructing a highway through and across certain land in Section Twenty T_h ree (23), Township Twenty One (21), Range Twelve (12) East, it is necessary to acquire a strip of land particularly described as follows:
