 office of the County Clerk.

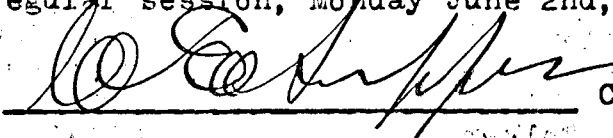
