RESOLUTION AND ORDER APPOINTING AN AGREED ESCROW AGENT TO HOLD A WARRANT FOR \$3,500.00 THIS DAY DRAWN, BY TULSA COUNTY DRAINAGE DISTRICT NO 12, PAYABLE TO SOUTHWESTERN BELL TELEPHONE COMPANY OF OKLAHOMA, TO SATISFY AND GUARANTEE SAID DRAINAGE DISTRICTS! OBLIGATION, UNDER THE TERMS OF A WRITTEN AGREEMENT BETWEEN SUCH PARTIES, WHEN DUE AND PAYABLE.

WHEREAS, on the 13th day of September, 1943, Tulsa County Drainage District No. 12 of Tulsa County, Oklahoma, and Southwestern Bell Telephone Company of Oklahoma, entered into a written agreement, under the terms of which, said telephone company agreed to remove and relocate, certain poles, wires and other equipment, so as to clear the proposed right-of-way, within and adjacent to said Drainage District, to enable it to construct certain levees, drains and ditches, to control flood waters of Arkansas River in that area, for the agreed consideration stated therein, and,

WHEREAS, said contract provided in substance, that before any alterations or changes in location, or otherwise, of any portions of said Telephone Companys equipment should be made, said Drainage District, would place in escrow \$3,500.00 to guarantee and assure prompt payment of said Telephone Companys' account for such changes and alterations, as stated in said contract, when completed.

NOW, THEREFORE, in compliance with such escrow provision in said contract, it is hereby Resolved and Ordered, by said Drainage District Commissioners, that Wood & Craig, Engineers for said District project, make the proper claim or voucher, for a warrant in favor of Southwestern Bell Telephone Company for \$3,500.00 drawn against said Drainage District funds by proper officers, and:

IT IS FURTHER RESOLVED AND ORDERED, by said Drainage District Commissioners that said warrant when properly drawn and approved, be immediately placed in the hands and custody of Andy Stokes, as County Clerk, and Ex-officio clerk of said Board of District Commissioners, as the agreed escrow agents of the parties to said contract, to guarantee and assure the prompt payment of said Drainage Districts obligation, under the terms of said contract, to Southwestern Bell Telephone Company when said contract has been completed.
