Penn covering realestate in Tulsa County, Oklahoma, for the years 1929, 1930, 1931 and 1932, be and the same is hereby granted and the County Clerk is hereby instructed to issue a certificate of error covering same. Upon roll call, all members voting in the affirmative, motion was by the Chairman declared carried.

Motion by Commissioner Hopkins, seconded by Commissioner Gray, that the affidavit of erroneous assessment filed by Mamie Gladys Lee covering Lots 6 and 7, Block 15, Summitt Hts. Addition to the City of Tulsa, Tulsa County, Oklahoma, for the years 1930, 1931 and 1932, be and the same is hereby approved and the County Clerk is hereby instructed to issue a certificate of error covering same. All members voting in the affirmative, motion was by the Chairman declared carried.
