Hon. Board of Commissioners of County of Tulsa,
State of Oklahoma.

The undersigned does hereby respectfully request that the Board of Commissioners of the County of Tulsa, State of Oklahoma grant him an easement along the West side of the County Highway which is an extension northward of Peoria Avenue in the City of Tulsa, Oklahoma, being the Highway on the East side of Township 20, North, Range 12 East of the Indian Base and Meridian, running from the high pressure line from Mohawk Pump Station to high-pressure reservoir of the City of Tulsa, along the West side of said highway to the quarter section corner on the East side of Section 12, Township 20 North, Range 12 East, of the Indian Meridian in Tulsa County, Oklahoma.

Your Petitioner agrees that in putting down such lines he will comply with all the laws of the State of Oklahoma, governing the construction laying and operation of said lines and likewise will comply with all the rules and regulations provided by this Board or other competent authorities of the State of Oklahoma governing the construction of pipe lines, the said Easement herein applied for being for a two-inch water pipe line.

IN RE application of Oklahoma Natural Gas Company a corporation, of Tulsa, Oklahoma, to construct pipe lines along and under public highways of Tulsa County, State of Oklahoma, to-wit:

Beginning at a point near the Northwest corner of Section 2, Township 18 North, Range 12 East, thence running Northwesternly, westerly and southwesterly, to a point near the Northeast corner of Section 4, Township 18 North, Range 12 East, crossing the intersection Section lines between Sections 2 & 3, (T. 18 N. R. 12 E) and Sections 34 & 35 (T 19 N R 12 E.) also crossing the intersection section lines between Sections 3 and 4 (T 18 R 12 E) and Sections 33 & 34, (T 19 N R 12 E.,) to be known as "Line A-134", a four inch (4") gas pipe line.

NOW, ON This 24th. day of November, A.D. 1924, at a regular meeting of the Board of County Commissioners of Tulsa County, Okla., held in compliance with and according to law, the application of OKLAHOMA NATURAL GAS COMPANY, a corporation, of Tulsa, Oklahoma for the right to put down, construct and operate its four inch gas pipe line known as "Line A-134", along and under the above specified public highways of Tulsa County, Oklahoma which application is in writing and sets forth that it is necessary for the purpose of further advancing the business of said Company in the purchasing, producing marketing, transporting and conveying of natural gas as in said petition stated, to lay, construct operate and maintain said pipe line along and under the specified public highways of Tulsa County, Oklahoma, comes on to be considered and said Board after hearing said application and considering same and being fully advised in the premises finds that said application should be granted.

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED, That Oklahoma Natural Gas Company of Tulsa, Oklahoma, be and the same is hereby authorized and empowered to lay, put down, construct, maintain and operate this its said gas pipe line for the conveyance, transmission and transportation of natural gas along and under the said specified public highways of Tulsa County, Oklahoma.

IT IS FURTHER ORDERED, That said gas pipe line be buried so as not to interfere with the ingress and egress of adjacent farmers at the ordinary places of entrance to their lands, and at such other places along said highway where abutting land owners may
