In the matter of the petition of the OKLAHOMA NATURAL GAS CORPORATION, the following order was made:

#### O R D E R

NOW, On this the 21st. day of October, 1929, the matter of the Petition of the Oklahoma Natural Gas Corporation for permission to lay a pipe line along, under and across certain highways in said County and State came up before the Board of County Commissioners of said County for hearing, and it appearing to the Board and each of the Commissioners thereof that it was just that the said Oklahoma Natural Gas Corporation be permitted to use as much of the highways as designated by plat filed by said corporation, and according to said description, which is as follows, to-wit:

A 4" line extending from the intersection of said East 51st. St. and Street between Blocks 2 and 3 of Villa Grove Sub Division, and along the West Side of said Street, North to and across East 48th. Street; a 4" line extending North from the intersection of East 51st. Street and McCrory Avenue to the North end of said Avenue; also a 4" line running East from McCrory Avenue from West side of McCrory Avenue along the North side of the street running East and West through Claypool Addition to South Harvard Addition; also a 4" line running from the West side of McCrory Avenue and along the North side of East 48th. Street to South Harvard Avenue; also a 4" line running East from the West Side of South Lewis Avenue along the North side of East and West Street of Barrow's Orchards Acres Addition, for a distance of 1322'; all being within Section 29, Twp 19, Rge. 13.

Also, an 8-5/8" low pressure gas pipe line on the West Side of South Lewis Avenue from 38th. Street South and across 41st. Street.

Also, an 8-5/8" gas pipe line along the North side of 51st. Street from College Avenue East to a point approximately 600' East of Harvard Avenue and within the SW/4 of Sec. 28, Twp 19, Rge. 13 E.

And, it further appearing from the Petition herein that said pipe line will be so constructed as not to interfere with any of the rights of the general public in the use of said highways; and will be constructed in accordance with all rules of The County Commissioners and the laws of the State of Oklahoma governing same.

IT IS HEREBY ORDERED AND ADJUDGED by the Board of County Commissioners of said County that permission be granted, and the same is hereby granted to OKLAHOMA NATURAL GAS CORPORATION, its successors and assigns, to use as much of the highways as above designated.

The following Resolution was introduced by Mr. North, seconded by Mr. Dickey, and the Chairman ordered the Resolution read:

#### R E S O L U T I O N.

WHEREAS, for the purpose of constructing a highway through and across certain land in Section Thirty Two (32), Township Nineteen (19), North, Range Thirteen (13), East it is necessary to acquire a strip of land particularly described as follows:

N $\frac{1}{2}$  "A strip of land for highway purposes, said strip being the East 15.25 feet of the West Forty (40) feet of the North Half N $\frac{1}{2}$  of N $\frac{1}{2}$  of SW $\frac{1}{4}$  of SW $\frac{1}{4}$  of NW $\frac{1}{4}$  of Sec. 32, T 19 N., R 13 E., Tulsa County, Oklahoma, containing 0.06 acres, more or less. The West 24.75 feet of the said N $\frac{1}{2}$  of N $\frac{1}{2}$  of SW $\frac{1}{4}$  of SW $\frac{1}{4}$  of NW $\frac{1}{4}$  of Section 32 is already County Road right of Way; the total road right of way on the East side of Section line after the execution of this deed being forty (40') feet wide.

AND, WHEREAS, Tulsa County has been unable to affect an amicable settlement in the matter of the said strip of land owned by H A BIEBER.

AND, WHEREAS, it is necessary to acquire said strip of land for right of way purposes by condemnation proceedings.

NOW, THEREFORE, BE IT RESOLVED, That the County Attorney, in the name of this Board for and on behalf thereof, be and he is hereby instructed to institute condemnation proceedings in the District Court of this County for the purpose of condemning said above described tract of land for County Highway purposes.

AND, BE IT FURTHER RESOLVED, That this Resolution is in lieu of a Resolution passed by this Board on September 3rd. 1929, condemning land for highway purposes from H A BIEBER.

All members voting in the affirmative, the resolution was declared adopted as read.
