Upon Motion of Commissioner W. L. North the followinf resolution was passed.

RESOLVED, Whereas, the State Highway Commissioner has promised to aid Tulsa County in constructing its system of improved roadways by recommending that the sum of \$600,000.00, Federal Aid be granted to said county, and

Whereas, the proceeds of the Bond Issue voted for the purpose of building these roads is sufficient to construct the proposes system without aid.

Now therefore be it resolved, by the Board of County Commissioners of Tulsa County, that should such system of raads be built with the aid of the Federal Government, the maintaining of same will be well and promptly done by the County of Tulsa and that as much as necessary to properly perform such work of maintenance will be expended each year, from the County Road Maintenance Fund of said County, which fund amounted to \$48000.00 for the fiscal year ending June 30th, 1918 and which under the law governing the estimates, can be only estim-  
ated as equal to that amount for the fiscal year ending June 30th, 1919.

Passed and approved this 29th day of May, 1919.

A motion was made by W. L. North and seconded by C. E. Suppes that the section line between Sections 33 Township 20 Range 13, and Sedtion 4 Township 19, Range 13, be and is hereby declared open for public travel; and the Twonship road Supervisor, J. E. Shaw, be instructed to grade said Raodway for public travel by order of the Board this 2nd day of June, 1919.
