RESOLUTION:

WHEREAS, The Department of Highways of the State of Oklahoma has notified the Board of County Commissioners of Tulsa County, that the sum of Thirty Nine Thousand Four Hundred Ninety Two and 27/100 \$39,492.27) of Federal Aid Road Fund has been apportioned to said County for expenditures during the Fiscal Year ending June 20, 1923.

WHEREAS, it is necessary that this County raise a sum of money equal to the portion of such allotment of Federal Aid Fund accepted by said County, to be expended in connection with same under the direction of the State Department of Highways, as authorized by Law, and

NOW, THEREFORE, BE IT RESCLVED, By the Board of County Commissioner of Tulsa County, that the sum of One Hundred Seventeen Thousand Nine Hundred Seventeen and 73/100 Dollars (\$117,917.73) or so much as may be necessary to complete the project secured from the revenue of such county or from other sources, be set aside by said County for expenditure in connection with such Federal Aid Allotment under the direction of the Commissioner of Highways of the State of Oklahoma, in accordance with the laws governing his Department, on road or bridge construction projects selected by him for such County and approved by the Bureau of Public Roads of the United States Department of Agriculture, and the members of the Board of the Board of County Commissioners do hereby pledge themselves to include in the Budget for the fiscal year ending June 30, 1923, the amount of money above stated to be used for the purpose above outlined, and to recommend to the County Excise Board that the same be approved, and
