## THURSDAY, JANUARY 13TH, 1944

Pursuant to recess heretofore taken, the Board of County Commissioners reconvened at the hour of 2:00 o'clock P. M., with the following members present. J. B. Gray, Chairman, Curtis Greer, Member. Andy Stokes, County Clerk. Robt. L. Kinkaid, Member, absent.

J. B. Gray, Chairman presiding, the following business was transacted.

Motion made by Commissioner Greer, seconded by Commissioner Gray, to approve the bond of Russell Lee Nixon, Deputy Civil Court Clerk of the Court of Common Pleas, Tulsa County, Oklahoma, as principal, and the Standard Accident Insurance Company, as surety, in the amount of \$1,000.00. Bond No. 871. Same was ordered filed. Upon roll call, both members voting in the affirmative, motion was by the Chairman declared carried.

Motion made by Commissioner Greer, seconded by Commissioner Gray, to approve the bond of Alvin Ross White, Minute Clerk of Common Pleas Court, Tulsa County, Oklahoma, as principal, and Standard Accident Insurance Company, as surety, in the amount of \$1,000.00. Bond No. 872. Same was ordered filed. Upon roll call, both members voting in the affirmative, motion was by the Chairman declared carried.

Motion made by Commissioner Greer, seconded by Commissioner Gray, approving the affidavit of erroneous assessment filed and approved by Dan A. Rowe, County Assessor, in favor of F. C. Abbot, Personal-1943 in the amount of \$5.11, be and the same is hereby approved. The County Clerk is hereby instructed to issue a certificate of error covering same. Upon roll call, all members voting in the affirmative, motion was by the Chairman declared carried.

Mr. Paul Pinson and Jack Campbell, Attorneys for the Oklahoma Natural Gas Company, appeared before the Commission for the purpose of endeavoring to amitably adjust a question relative to the Miscellaneous Assessment against the Oklahoma Natural Gas Company in connection with the Arkansas River Levee in Drainage District No. 12. Mr. Conn Lynn, Attorney and Mr. C. J. Rust, W. O. Dickenson and Robt. G. Frye, Viewers for Drainage District No. 12, were also present. Mr. Pinson's contention was that the assessment against the Oklahoma Natural Gas Company was not only erroneous and invalid but that it was absolutely void as it was made against the individual corporation and not against land. The Oklahoma Natural Gas Company agreed to make a contribution of \$500.00 toward the levee project and Mr. Pinson introduced a telegram from Mr. Fred Peters, Treasurer, stating this fact but the Viewers for the District contends that the original agreement was that they were to pay \$500.00 per year for ten years or a total contribution of \$5,000.00 to the district. As there was no settlement made in this matter the meeting was adjourned until a future date.
