RESOLUTION

WHEREAS, a portion of the East 313.5 feet of the NE_4^1 of the NW_4^1 of Sec. 34, Twp. 19 N. Range 12 E., Tulsa County, Oklahoma, is needed by the County of Tulsa in connection with acquisition of right-of-way for the 51st Street Project; and

Whereas, said property can be acquired by amicable settlement from the owners, Harold Leo Whitehead and Ella Whitehead, his wife, and from United Federal Savings and Loan Association of Tulsa, for a consideration of \$3,000.00, which amount is deemed to be fair and reasonable.

NOW THEREFORE BE IT RESOLVED that the County purchase a portion of the East 313.5 feet of the NE_{4}^{1} of the NW_{4}^{1} of Sec. 34, Twp. 19 N. Range 12E., Tulsa County, Oklahoma, more particularly described as follows, to-wit:

Commencing at a point on the East line of the $NE_{4}^{\frac{1}{4}}$ of the $NW_{4}^{\frac{1}{4}}$ of said Section 34-19-12, said point being 282 feet South of the Northeast corner thereof; thence South along said East line of said $NE_{4}^{\frac{1}{4}}$ of the $NW_{4}^{\frac{1}{4}}$ of said Section 34-19-12, a distance of 175 feet to a point; thence West along a line parallel to the North line of said Section 34-19-12, a distance of 160 feet to a point; thence South and parallel to the said East line of said $NE_{4}^{\frac{1}{4}}$ of the $NW_{4}^{\frac{1}{4}}$ of said Section 34-19-12, a distance of 23 feet to a point; thence West and parallel to said North line of said Section 34-19-12 a distance of 153.5 feet to a point; thence North and parallel to the said East line of said $NE_{4}^{\frac{1}{4}}$ of the $NW_{4}^{\frac{1}{4}}$ of said Section 34-19-12, a distance of 198 feet to apoint; thence East along a line parallel to the said North Line of said Section 34-19-12, a distance of 198 feet to apoint; thence East along a line parallel to the said North Line of said Section 34-19-12, a distance of 313.5 feet to the place of beginning,

paying therefor the sum of \$3,000.00 upon claim executed by the said owners, and by the United Federal Savings and Loan Association of Tulsa, as its interest may appear.

RESOLUTION

WHEREAS, property owners residing in the vicinity of 57th West Avenue and the Missouri, Kansas & Texas Railroad, in Sec.5, Twp. 19 N. Range 12 E., Tulsa County, Oklahoma, have petitioned the Board to procure the opening of 57th West Ave. over and across the M. K. & T. Railroad; and

WHEREAS, it appears that, as represented by said petitioners, the opening of this street is necessary for the welfare and safety of the residents in this vicinity, and that there are over 250 homes in this vicinity with only one wad entrance, which is from the East off 49th West Avenue, and that said single road is encompassed and closed in on the North b a levee, and on the South by the M. K. & T. Railroad, and on the West there is no outlet, and that the children residing in the homes in this vicinity attend Riley School, which is directly South of the requested railroad crossing on 57th West Avenue, and that said children are required, by reason of the lack of a crossing over said railroad, to go East 3/4th of a mile, then South and back West 3/4th of a mile to reach the school by public road;

NOW THEREFORE BE IT RESOLVED that the Corporation Commission of the Atate of Oklahoma be, and it is hereby requested to require the Missouri, Kansas & Texas Railway Company to promptly open 57th West Avenue at M. K. & T. Railroad in Sec. 5, Twp. 19 N. Range 12 E., Tulsa County, Oklahoma, and to provide suitable and appropriate crossing thereat.

BE IT FURTHER RESOLVED that a copy of this Resolution, together with a copy of said petition, be sent the Corporation Commission with the request that said matter be set down for hearing at an early date, and that this Board and the County Attorney be advised of the date of said hearing in order that property owners, county officials and interested parties may be present and be heard.
