KNOW ALL MEN BY THESE PRESENTS: That the County of Tulsa in the State of Oklahoma, by its Board of County Commissioners, hereby acknow ledges itself indebted to and for value received promises to pay to the bearer the sum of ONE THOUSAND (\$1,000.00) DOLLARS on the first day of January, A. D. 19____, together with interest thereon from the date thereof until paid at the rate of _____ per centum per annum, payable semi-annually on the 1st day of January and July of each year, excepting the first interest coupon which shall mature January 1 1947; said interest evidenced by and to be paid upon the surrender of the coupons heretof attached as they severally become due, both principal and interest payable in lawful money of the United State of American at The First National Bank and Trust Company of Tulsa, Tulsa, Oklahoma or, at the option of the holder, at the Fiscal Agency of the State of Oklahoma in the city of New York, State of New York or in the event of the discon- tinuance of such agency, then at the Manufacturers Trust Company in said city and State of New York.

THIS BOND is one of a series numbered from one to one thousand seven hundred fifty, inclusive, of like date and tenor except as to date of maturity and rate of interest, aggregating the principal sum of ONE MILLION SEVEN HUNDRED FIFTY THOUSAND (\$1,750,000.00) DOLLARS and is issued for the purpose of providing funds for the purpose of building and repairing bridges and constructing permanent state roads within and for and to be owned and controlled exclusively bysaid county, under and by virtue of Section 26, Article 10 of the Constitution of Oklahoma and Title 69, Sections 161 to 170, both inclusive, Oklahoma Statutes, 1941 and other statutes of the state complementary, supplementary and enacted pursuant thereto.

THE FULL FAITH, CREDIT AND RESOURCES of said county are hereby irrevocably pledged to the payment of this bond.

IT IS HEREBY CERTIFIED AND RECITED that all acts, conditions and things required to be done precedent to and in the issuance of this bond have been properly done, happened and been performed in regular and due form and time as required by law and that the total indebtedness of said county including this bond and the series of which it forms a part, does not exceed any constitutional or statutory limitation and that due provision has been made for the collection of an annual tax sufficient to pay the interest on this bond as it falls due and also to constitute a sinking fund for the payment of the principal hereof at maturity.
