IT IS FURTHER PROVIDED that in the event of the assignment to creditors by the party of the second part, or either of them, or the institution of bankruptcy proceedings against the party of the second part, or either of them, such events, or either of them, shall forthwith and of itself cancel and hold for naught this lease, and all rights thereunder, and possession of said property shall immediately, by such act or acts, pass to the party of the first part, at his option.

THE PARTY OF THE SECOND PART forther agrees that after the expiration of the time given in the lease, to-wit: the 3rd day of August, 1935 without notice from the first party, to give possession of said building and all equipment to said party of the first part, loss by fire alone excepted. The destruction of the building on said premises by fire shall work a termination of this lease.

Party of the first part agrees to furnish water necessary for the use of the Hospital to be conducted on said premises, during the term of this lease, said water to be furnished free of charge to the party of the second part.
