

Motion was made by Mr. North, seconded by Mr. Hedgecock, that the County Clerk be and he is hereby directed to prepare a Financial Statement of the General Fund, also a Financial Statement of the County Highway Fund as at the close of business May 31st. 1927. Carried.

Upon motion of Mr. Hedgecock, seconded by Mr. North, the County Engineer is hereby directed to order gravel and have same distributed for maintenance purposes on Miles Six (6), Seven (7), Nine (9), Ten (10) and Eleven (11) of Section "U U" and the recently improved highway between Sections 2-11, 10-11, 10-15, 9-16, Township 16 North, Range 13 East. Carried.

Upon motion of Mr. Hedgecock, duly seconded by Mr. Stuckey, the County Engineer is hereby directed to order gravel and have same distributed for maintenance purposes on Miles Two (2), Three (3), Four (4), Five (5) and Six (6) of Section "W", the same being the designated County Highway South of Bixby to Okmulgee County Line. The motion receiving a majority of the votes, was declared carried.

Motion was made by Mr. Hedgecock, seconded by Mr. Stuckey, that the County Engineer be directed to order gravel and have same distributed for maintenance purposes on Miles Three (3), Four (4) and Five (5) of Section "V", and Miles One (1) and Two (2) of Section "U"; the same being the designated County Highway from Bixby to Hilltop. The motion receiving a majority of the affirmative vote was declared carried.

Motion was made by Mr. North, seconded by Mr. Hedgecock, that Tulsa County join with the City of Tulsa in paving that portion of Fifteenth Street (15th) in Section Eight (8), Township Nineteen (19), Range Thirteen (13) East, outside of the City Limits and opposite Rosemont Heights Sub Division according to the plans of the City Engineer. ORDER APPROVING BOND, and APPOINTING VIEWERS

NOW, On this 16th. day of May, 1927, the same being one of the regular days of the May 1927 meeting of the Board of County Commissioners of Tulsa County, Oklahoma, there having come on for hearing before the Board of County Commissioners of Tulsa County, Oklahoma, a petition signed by S P Ross and C M Bowen and others, containing the signatures of more than five residents of Tulsa County, who claim to be affected by the proposed drain and other improvements, to be assessed for the construction thereof, praying for the creation of a drainage and improvement district within Tulsa County, Oklahoma, and setting forth the necessity thereof, with a general description of the proposed drain and other improvements, the starting point, route and terminus of said proposed drain and other improvements, and that it was desired to issue bonds and other evidences of indebtedness to meet the expense of such improvements; the signers of said petition numbering five or more residents of Tulsa County, who claim to be affected or benefitted by such drain and other improvements; and there having been filed a bond with said petition, in the sum of not less than Fifty (\$50.00) Dollars for each mile of the length of the proposed drain and other improvements, payable to the State of Oklahoma, signed by one or more of the petitioners, and at least two good and sufficient sureties, conditioned for the payment of all costs and expenses, if the prayer of the petitioners be denied or dismissed for any cause which said bond has been, and is hereby approved by the Board of County Commissioners of Tulsa County, Oklahoma.
