THIS BOND is one of a series numbered from one to one thousand, inclusive, of like date and tenor except as the date of maturity and rate of interest, aggregating the principal sum of ONE MILLION (\$1,000,000.00) DOLLARS and is issued for the purpose of purchasing school sites, erecting school buildings, purchasing school furniture and fixtures, making school building repairs and making school site improvements, all for the permanent improvement of the separate schools of said Tulsa County, to be owned exclusively by said county, under and by virtue of Section 26, Article 10 of the Constitution of Oklahoma and Title 70, Sections 907.1 to 907.7, both inclusive, Oklahoma Statutes, 1941 and other statutes of the state complementary, supplementary and enacted pursuant thereto.

THE FULL FAITH, CREDIT AND RESOURCES of said county are hereby irrevocably pledged to the payment of this bond.

IT IS HEREBY CERTIFIED AND RECITED that all acts, conditions and things required to be done precedent to and in the issuance of this bond have been properly done, happened and been performed in regular and due form and time as required by law, and that the total indebtedness of said county, including this bond and the series of which it forms a part, does not exceed any constitutional or statutory limitation and that due provision has been made for the collection of an annual tax sufficient to pay the interest on this bond as it falls due and also to constitute a sinking fund for the payment of the principal hereof at maturity.
