

the Drainage Laws of the State of Oklahoma, as amended and codified and signed by the requisite number of petitioners.

And, the Board finding that it is necessary that a Board of Viewers should be appointed, who shall proceed at once, under the direction and order of the Commissioners, certified by the County Clerk, to view the line of proposed drain and other improvements, and report after actual view of the premises lying and adjacent thereto, whether the proposed improvement is practicable and necessary, of benefit, or of private or public utility as prescribed by law.

And, the Board finding that A W Lucas and P L Price and Cyrus S Avery are resident freeholders of Tulsa County, and not interested in the construction of said work, and not of kin to any person interested therein, and that Victor H Cochrane is a competent Engineer to assist the Board of Viewers, so appointed.

NOW, THEREFORE, It is ordered that the said A W Lucas and P L Price and Cyrus S Avery be and they are hereby appointed a Board of Viewers, to proceed to actual view of the line of the proposed drain and other improvements, and report after actual view of the premises along and adjacent thereto, whether the proposed improvement is practicable and necessary, or of private or public utility and benefit, as set out by the petition filed herein, as described by law, to the Board of County Commissioners of Tulsa County, Oklahoma.

And, it is further ordered that Victor H Cochrane be and is hereby appointed Engineer to assist the Viewers heretofore appointed as provided by law.
