AUTHORITY TO THE COUNTY WELFARE ADVISORY BOARD

BY

THE COUNTY COMMISSIONERS.

The County Commissioners hereby create and name a County Welfare Advisory Board of seven members and assign to it the duties of Advising with the County Commissioners and the County Welfare Department relative to the administration, personnel, expenditures and needs of the said County Welfare Department; to recommend to the County Commissioners and to co-operate with all allied organizations within the city and county and state.

The Advisory Board shall effect its own organization: Chairman, Vice-Chairman and Secretary.

Meetings of the Board shall be upon call of the chairman and secretary; or of any two members of the Board, and shall be held at such time and place as the chairman or those calling the meeting shall designate.

A quorum of the Board shall be three members.
