A RESOLUTION APPLYING AND PLACING IN FORCE AND EFFECT, IN TULSA COUNTY, OKLAHOMA, THE PROVISIONS OF SECTIONS 811 to 828, BOTH INCLUSIVE OF TITLE 19, OKLAHOMA STATUTES ANNOTATED, RELATING TO THE ESTABLISHMENT OF COUNTY LAW LIBRARIES, AND APPOINTING AND DESIGNATING A REPRESENTATIVE OF

THE BOARD OF COUNTY COMMISSIONERS TO THE BOARD OF LIBRARY TRUSTEES OF TULSA COUNTY.

BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF TULSA COUNTY, STATE OF OKLAHOMA, IN REGULAR SESSION ASSEMBLED ON THIS 31st DAY OF OCTOBER, 1949; THAT -

- (1) Pursuant to the authority and the provisions set forth in Section 824, Title 19, Oklahoma Statutes, as amended, the provisions of Section 811 to 828, both inclusive of Title 19, Oklahoma Statutes Annotated, are hereby placed in force and effect in Tulsa County, State of Oklahoma, and the creation and establishment of a County Law Library in accordance with the provisions of the last designated statutory provision is hereby authorized and directed.
- (2) This Resolution shall be effective, commencing with the 1st day of November, 1949.
- (3) It is further resolved that J. W. Hardesty is hereby designated and appointed by the Board of County Commissioners as the representative member of the County Commissioners on the Board of Library Trustees, provided for in the last designated statutory provision.
- (4) It is further resolved that the Court Clerk of Tulsa County State of Oklahoma, is hereby directed and authorized to create a separate fund to be designated as "Law Library Fund", and to charge such costs as are authorized and provided for in the provisions of the hereinbefore designated statutory provisions, commencing on the 1st day of November, 1949.
