RESOLUTION

It appearing that on the 10th day of April, 1948, Pearl Reber executed unto Tulsa County, State of Oklahoma, an easement deed covering land situated in Tulsa County, Oklahoma, to-wit:

Beginning at a point nineteen hundred eighty (1980) feet East of the Northwest corner of Section 35, Township 19 North, Range 12 East and running thence southerly a distance of 1,320 feet to the center of the North line of the SE $\frac{1}{4}$ of the NW $\frac{1}{4}$ of said Section 35, and running thence easterly along the North line of said SE $\frac{1}{4}$ of the NW $\frac{1}{4}$ of said Section for a distance of 20 feet, and running thence Northerly for a distance of 1,320 feet to the North line of said Section 35, and running thence westerly along the North line of said Section 35, a distance of 20 feet to the point of beginning, and being a tract of approximately 20 feet by 1,320 feet, and which said tract of land has heretofore been used for a number of years as a roadway or highway for the contiguous and adjoining owner of land thereto,

which said deed is recorded in the office of the County Clerk of said County in Book 1890, at page 498, and it appearing that the description of the property intended to be conveyed was incorrectly described therein, and that thereafter, on the 5th day of November, 1951, Pearl Reber, the then owner of said above described parcel of land and other land adjacent thereto, did execute unto Tulsa County, Oklahoma, a corrected easement deed of the parcel of land hereinafter described.

BE IT THEREFORE RESOLVED that the Board of County Commissioners of Tulsa County, Oklahoma, does hereby relinquish all the right, title or interest the said County of Tulsa may have acquired in and to the above described land by virtue of easement deed on file in the office of the County Clerk of Tulsa County, Oklahoma, recorded in Deed Records in Book 1890, at page 498 therein, but asserting its title in and to land situated in Tulsa County, Oklahoma, to-wit:

Beginning at a point on the North line of Section 35, Township 19 North, Range 12 East in Tulsa County, State of Oklahoma, said point being 594 feet West of the Northeast corner of the NW $\frac{1}{4}$ of said Section 35, thence South and parallel to East line of said NW $\frac{1}{4}$ of Section 35, a distance of 1,320 feet more-or-less to a point on the South line of the NE $\frac{1}{4}$ of the NW $\frac{1}{4}$ of said Section 35, thence West on the South line of said NE $\frac{1}{4}$ of the NW $\frac{1}{4}$ of Section 35 a distance of 20 feet to a point, thence North and parallel to the East line of said NW $\frac{1}{4}$ of Section 35 a distance of 1,320 feet more-or-less to a point on the North line of said Section 35, Township 19 North, Range 12 East, thence East on the North line of said Section 35 a distance of 20 feet to the point of beginning.
