

Additional memorandum will be submitted at your request showing you the condition of the several appropriations accounts as of May 31st, 1911, together with all claims which are on file which are incumbrances to said appropriations. In your recommendations to the County Excise Board considerations must be taken of:-

First: Overdrawn Appropriations.

Second. Amounts necessary to continue operation in the several offices and departments for the remainder of the fiscal year, which in brief means that you have the expenses of two months to take care of.

you are also charged with the knowledge that your appropriations are your maximum and final limitation as to expenditures for the fiscal year, and no claims or obligations arising within the current fiscal year may legally be paid out of the appropriations made for the subsequent fiscal year. To so "kite" claims is a violation of both the constitution and the statutory laws of the state and make the County Commissioners personally liable on their bonds.

In conclusion I will state that the supplemental appropriations requested may be equal to your surplus and cancellations but in no event exceed such sum total. Therefore, you have available for additional appropriations the sum of \$89,113.77, and in your request this should be apportioned as to prevent any financial embarrassment to any department of the County and at the same time to take care of all legal obligations of the County.

"MINUTES OF THE MEETING OF THE EXCISE BOARD
OF TULSA COUNTY, OKLAHOMA."

Pursuant to a legal call heretofore made, the County Excise Board of the County of Tulsa, State of Oklahoma met on the 16th day of June, 1919, at the hour of Nine O'clock A. M. in the office of the county clerk of said county, and the following proceedings were had.

Present and voting: Lewis Cline, County Clerk and ex-officio secretary of the Board, W. S. Hooker, County Assessor, W. B. Williams, County Judge, Ed Dalton, County Treasurer, Thos. I. Munroe, County Attorney, C. E. Suppes, Chairman of the Board of County Commissioners, W. L. North, Commissioner, and R. A. Martin Member of the Board of County Commissioners.

Absent: Minnette Hedges, County Superintendent of Public Instruction.

The application of the honorable Board of County Commissioners of Tulsa County requested the cancellation and revocation of certain unexpended appropriations of the General Fund of said County and an application for the supplemental appropriation to meet the legal requirements and the ordinary expenses of said county for the remainder of the fiscal year 1918-1919.

That the said appropriations requested and submitted for cancellation and revocation and the balance available for the remainder of the fiscal year of 1918 and 1919 are set out and contained in Exhibit "C" of said application and the list and statement of the purposes and amount deemed necessary to meet the legal and necessary expenses of Tulsa County for the remainder of the fiscal year ending June 30th, 1919, are set out shown and contained in Exhibit "A" of said applications.

And that accompanying said application and a part thereof and attached thereto and Marked Exhibit "B" is a FINANCIAL STATEMENT at the close of the month of May 31st, 1919 certified by the duly qualified and acting County Clerk and County Treasurer of said County.

And after hearing said application and being fully advised in the premises the said Excise Board finds that notice of this application has been fully published as required by law and that each officer effected thereby has been duly notified and we further find that said unexpended balances and parts thereof as set out in said Exhibit "C" should be cancelled and revoked and reappropriated for other purposes, THEREFORE, it is moved by W. L. North and Seconded by Ed Dalton that said appropriations or parts thereof be cancelled and be made available for re-appropriation for other than the necessary purposes. Said motion being duly seconded the same was by the Chairman put to a vote. All voting in favor of the motion the motion was declared carried and the said appropriations and parts thereof amounting to the total sum of \$37,874.00 were ordered cancelled.

And we further find from said application that the sum of \$81,909.11 is available for reappropriations and it was moved by Lewis Cline, County Clerk and Seconded by Thomas I. Munroe, County Attorney, that of the said amount the sum of \$81,614.58 be appropriated to the several accounts as shown and listed in exhibit "A" of said application. Said motion being submitted to a vote and all voting in favor thereof the motion was declared carried and the secretary of this Board and the County Clerk and the several officers affected by these proceedings were hereby ordered to correct their several records to show said cancellations and reappropriations.
