Motion was made by Ira Short, seconded by Geo.E.Gilmore, that the report of Mr. Ed O.Casidy, Deputy State Examiner and Inspector, be approved and filed and made of record. Motion carried.

Motion was made by Ira Short, seconded by Geo.E.Gilmore, that the Special Deputy State Examiner and Inspector be and he is hereby ordered to make an audit of Bond Forfeitures in all Courts since January 3rd. 1921 and it is further ordered that the Special Deputy State Examiner and Inspector be and he is hereby directed to make an audit of cash Voucher Claims and Cash Vouchers for all years. Motion carried.

Motion was made by Ira Short, seconded by Geo.E.Gilmore, that the request of the petitioners asking that the half section line running North and South through Section 32, Twp. 18, North/<sup>Range</sup>13 East, be granted on the condition that the Petitioners or the property owners, as the case may be, owning the land adjacent to the proposed road, be required to furnish and donate the right of way setting the fence back a distance of 25 feet on either side of the center line, and the County will grade the same and place it in a useable condition. Motion carried.

Motion was made by Ira Short, seconded by Geo.E.Gilmore, that the request of the Citizens of Willow Springs Township and Boles Township asking that the Section line between Sections 25 and 26, and 36 and 35 in Twp. 18 North, Range 14, East be surveyed with the view of improving the same by locating the road along or near the said line, be granted, if finances permit in accordance with the recommendation of the County Engineer. Motion carried.

Motion was made by Ira Short, that the petition of H.H.Dyer and 44 additional petitioners asking that the Section line road leading North from Bruner on the Sand Springs Road to Twin Cities and Farm Colony Addition be improved, in accordance with the recommendation of the County Engineer. Seconded by Geo.E.Gilmore. motion carried.




