In pursuance of the provisions of Section 8, of Chapter 226, Laws, 1917, application is hereby made for supplemental and additional appropriations with which to meet the legal and ordinary expenses of Tulsa County, Oklahoma, for the remainder of the fiscal ending June 30th, 1919, and for an order cancelling certain appropriations or parts theretofore mede for said year. In support thereof we do hereby certify.

First: That certain of the appropriations heretofore made are inadequate to properly maintain the county for the current fiscal year, and that the phic welfare and needs of saidCounty are such as to require, for the remainder of the said year, for legal and ordinary expenses, the additional appropriations as set forth by purposes and amounts in exhibit "A", hereto attached and made apart hereof.

SECOND; That the financial satement hereto attached and marked Exhibit "B" shows as of the cdose of the month next preceeding the filing hereof the true and correct fiscal condition of the said GENERAL FUND of said county, and that the sur plus revenure of #44,035.11 as shown in said exhibit is available for and out of which to make the additional appropriation wherein requested.

THIRD: That the appropriations as listed in Exhibit "C" hereof, aggregating \$37.874.00 are for purposes less urgent and imperative than the additional needs herein presented.

WHEREFORE, request is hereby made that an order be entered cancelling the said appropriations, and that the revenue so released, together with he above ststed surplus, making a total of available revenue of \$81,909.11 be applied and appropriated to the several additional and supplemental purposes as set forth in exhibit "A" hereof.

WE FURTHER CERTIFY, that theaggregate amount of the said proposed additional and supplemental appropriations in and not in excess of the income and revenue provided and accumulated for the current year.
