

Cooper the cost of taking said fence down, putting the same back up and for the removal of said personal property and the replacement thereof, which is to be figured at actual cost plus 15% for administrative purposes.

5. The Tulsa County Drainage District Number 12 further agrees to pay the actual cost plus 15% for administrative purposes for any work and material expended by Fred. E. Cooper in putting into the same condition as it is now, the property and real estate referred to in the easement, a copy of which is attached hereto, marked Exhibit B.

6. The Tulsa County Drainage District Number 12 agrees to pay Fred E. Cooper the cost of repairing and putting into the same condition as it is now, all real estate and improvements including all roads used for ingress and egress, whether covered by easement or not, if the same should be damaged in any way by reason of the construction and erection of said levee.

7. The Tulsa County Drainage District Number 12 agrees to replace and repair any and all sewers or pipes damaged or removed, whether the same be upon land covered by easement or not, and in the event that said Tulsa County Drainage District Number 12 fails to replace or repair all sewers and pipes, that the said Fred E. Cooper shall have the right to replace and repair same and that the Tulsa County Drainage District Number 12 will pay the actual cost of same plus 15% for administrative purposes.

8. The Tulsa County Drainage District Number 12 agrees to hold harmless the said Fred E. Cooper from all claims for damages arising of any act committed on premises upon which an easement has been granted arising through the fault of Tulsa County Drainage District Number 12, contractors or otherwise, and not through the fault of said Fred E. Cooper.

Easement and Right-of-Way referred to in above contract between Tulsa County Drainage District Number 12 and Fred E. Cooper is recorded in Book 1579 Page 482 Number 695021 also Miscellaneous Number 46627.

Motion made by Commissioner Gray, seconded by Commissioner Greer, to approve the cancellation of the Cattle Brand AT registered by A. H. Thomas, and also to approve the new one, a plain "T". Upon roll call, all members voting in the affirmative, motion was by the Chairman declared carried.

At a meeting of the Board of County Commissioners, held on the 31st day of January, 1944, at which all members composing said Board were present, the following Resolution was introduced by Commissioner Greer who moved its adoption; said Motion being seconded by Commissioner Kinkaid. The Chairman of the Board ordered the Resolution read, to-wit:

#### RESOLUTION

WHEREAS, Tulsa County owns Chevrolet Truck, 1939 Model, 1-1/2 Ton, the Motor Number of which is 11964963, and

WHEREAS, said Chevrolet Truck being in a state of bad repair and not generally serviceable for the uses and purposes of the Highway Department, to which said Chevrolet Truck belongs, and was purchased and paid for from County Highway Funds; and,

WHEREAS, the Highway Department is in need of an automobile, and has found that a trade or exchange can be made with Exchange Auto Parts for a 1935 Chevrolet Panel Truck, 1-1/2 Ton, Motor Number T4719492, Serial Number 9QB06-6152, in exchange for the Chevrolet Truck, and a further consideration of payment by Tulsa County to Exchange Auto Parts the sum of Five Hundred Sixty Eight Dollars (\$568.00).

NOW, THEREFORE BE IT RESOLVED, That the Chairman of the Board of County Commissioners be authorized to transfer title to the aforesaid Chevrolet Truck, and deliver same to Exchange Auto Parts in exchange for the said 1935 Chevrolet Panel Truck when accompanied by a proper transfer of title to Tulsa County, and that the County Highway Department be authorized to draw a Claim to the Exchange Auto Parts in the sum of Five Hundred Sixty-Eight Dollars (\$568.00), payable from Account Number 6B, designated as
