

Additional and Supplemental Appropriations

We find that the said application has been duly published as required by law; that the public welfare and needs of said county for the remainder of the current fiscal year, justify and require certain additional and supplemental appropriations; that of the appropriations heretofore made for the current fiscal year, that certain thereof as listed in Exhibit "C" to application are no longer required or may, in view of the other more urgent demands may be dispensed with for the year.

IT IS THEREFORE ORDERED, that the said appropriations as listed in Exhibit "C" be and are hereby revoked and cancelled in the several amounts as stated in Column 4 of said exhibit; and the County Clerk is hereby authorized and directed to enter the said cancellations of record in his office, and that no expense will be hereafter accrued or incurred against any one of the said appropriations.

WE FURTHER FIND, the said financial statement to be correct, that due and proper provisions has been made for the payment of all warrants with interest accrued and accruing thereon, and for the liquidation of the entire unexpended balance of appropriations as the same existed as to date of said financial statement; that the SURPLUS REVENUE in the GENERAL FUND is \$44,035.11; that the revenue released by the cancellation of appropriations as herein ordered amounts to \$37,874.00; and that said surplus and released revenue aggregating \$81,909.11 is available for additional needs and requirements of the County for the remainder of the Current Fiscal Year.

WHEREFORE, in consideration of the premises, we do hereby approve and make the additional and supplemental appropriations out of the respective funds indicated, and in the several amounts aggregating \$81,614.58, as listed in Column 4 of the said exhibit "A", and the County Clerk is hereby authorized to enter the said appropriations upon the books and records of his office and the same shall be available for the several named purposes for the remainder of the current fiscal year ending June 30th, 1919/

WE FURTHER CERTIFY, that the said additional and supplemental appropriations as approved, when added to the original appropriations for the fiscal year, less the cancellations made, are not in excess of the revenue and income provided and accumulated for the current fiscal year.


