Moved by Commissioner Caffey, seconded by Commissioner Bailey, that the following resolutions purchasing right-of-way property be approved. Upon roll call, motion carried.

RESOLUTION

WHEREAS, a portion of Lots 6, 7, 11, 12, 13, 14, 15, 16 and 17, Block 21, South Haven Addition, Tulsa County, Oklahoma, according to the Recorded Amended Plat thereof, is needed by the County of Tulsa in connection with acquisition of right-of-way for the 51st Street Project; and

WHEREAS, said property can be acquired by amicable settlement from the owners, Brooks Alexander and Mary Alexander, for a consideration of \$9,000.00, which amount is deemed to be fair and reasonable.

NOW THEREFORE BE IT RESOLVED that the County purchase a portion of Lots 13, 14, 15, 16 and 17, Block 21, South Haven Addition, Tulsa County, Oklahoma, according to the Recorded Amended Plat of said parcel of land, being more particularly described as follows:

Beginning at the Northwest corner of Lot 17 of said Block 21, thence East along the North line of said Lots 17, 16, 15, 14 and 13, thence South along the East line of said Lot 13, a distance of 42.47 feet to a point, thence Southwesterly across said Lots 13, 14, 15, 16 and 17 to a point on the West line of Lot 17, thence North along the said West line a distance of 78 feet to the Northwest corner of said Lot 17 and point of beginning;

and a portion of Lots 6 and 7, Block 21, South Haven Addition, Tulsa County, Oklahoma, according to the Recorded Amended Plat thereof, said parcel of land being more particularly described as follows:

Beginning at the Northeast corner of Lot 6 of said Block 21, thence South along the East line of said Lot 6 a distance of 1.61 feet to a point, thence Westerly to a point, said point being 23 feet West and 1.43 feet South of the Northeast corner of said Lot 6, thence Southwesterly to a point on the West line of said Lot 7, thence North along the West line of said Lot 7 a distance of 8.72 feet to the Northwest corner of said Lot 7, thence East along the North line of said Lots 7 and 6 to the Northeast corner of said Lot 6 and point of beginning;

and a portion of Lots 11 and 12, Block 21, South Haven Addition, Tulsa County, Oklahoma, according to the Recorded Amended Plat thereof, said parcel of land being more particularly described as follows:

Beginning at the Southeast corner of said Lot 11, thence North a distance of 101.03 feet to a point on the East line of said Lot 11, thence Southwesterly across said Lots 11 and 12 to a point on the West line of Lot 12, which point is 42.47 feet South of the Northwest corner of said Lot 12, thence East along the South line of Lots 12 and 11 to point of beginning,

paying therefor the sum of \$9,000.00 upon claim executed by said owners.

Lots 5, 6, 7, 8, 9, 10, 11, 12, 13, 14, 15, 16, 17, 18 and 19, Block 17;
